### 1. Introduction

- **Industry Partner (SME/Business):** For Australian-owned businesses (SMEs) looking to integrate into national supply chains and regional projects.
- **Institutional Partner (Corporate/Government):** For large-scale entities and government departments requiring high-level data transparency and national regional engagement frameworks.

### 3. Eligibility and Application

- **National Reach:** Membership is open to all Australian residents and entities with a valid ABN/ACN.
- **Values Alignment:** Applicants must formally agree to uphold the "Truth Hubs" values of integrity, transparency, and respect for the diverse cultures of Australia.
- **Regional Commitment:** Business members must demonstrate how their operations contribute to the local economies of the regions in which they operate.
